Introduction

Welcome to the Kings County NYC Health + Hospitals Fellowship in Emergency Medicine Administration. Kings County Hospital is located in the East Flatbush region of Brooklyn, NY, and serves as the primary source of care for more than 800,000 people in the surrounding areas. Established in 1830, KCH was named the country's first Level 1 Trauma Center and has an annual volume of more than 140,000 ED visits. The Emergency Department is home to one of the largest academic residency programs and the hospital is nationally recognized as a designated stroke center with an inpatient capacity of more than 624 patient beds.

The Kings County Emergency Medicine Administrative Fellowship provides all of the necessary elements to developing a great leader. Administrative fellows in our program will be actively involved in the daily operations of the emergency department and will also be exposed to the various divisions within the department such as Quality, Operations, and Performance Improvement. The fellow will have the opportunity to learn about hospital wide processes and will represent the emergency department on various hospital committees and initiatives. The two-year Administrative fellowship at KCH will be coupled with an Executive MBA through which the applicant will learn basic foundations in accounting, marketing, and leadership. The fellow will also receive a series of lectures from the Administrative Fellowship didactic curriculum (see page 6) to learn the essentials of managing a tertiary care academic emergency department of this size.
